- Richmond Region Tourism Jack Berry, who worked tirelessly to put the Richmond Region, including Hanover County, on national and international tourism maps, will enjoy a much-deserved retirement after 31 years with the organization. Katherine O'Donnell, with the organization since 2002, ascended to the role of president and CEO on July 1, 2024.

The Department of Economic Development wishes to thank these individuals for their collaboration and tireless work to help promote and strengthen the community. Hanover is a better place because of the devotion and dedication for which they have led these organizations. We look forward to working with their successors to fill the big shoes these individuals have left behind!

Fiscal year 2024 was another year of strong economic success in Hanover County. While some of the post-pandemic boom from logistics and onshoring has ebbed, activity is still well above pre-pandemic averages. And, other sectors such as data center, retail, and manufacturing are witnessing heightened activity this year.

Capitalizing on CNBC's ranking of Virginia as the Top State For Business in 2024 and the Richmond Region being named CNN Travel's Best Town to Visit 2024, Hanover County continues to see strong interest from prospects looking to establish a presence here. And it's not just new businesses moving into the County, existing

companies such as Lutron, Blazer Heating, Air & Plumbing, and Virginia Artesian among others continue to support the County by making significant investments in new and expanded operations.

Hanover County's economy remains strong and dynamic. The boom in warehousing and logistics has leveled resulting in slower demand for new speculative space thereby increasing vacancy from previous years. The demand for data center space has accelerated, and the reasons behind Hanover witnessing such strong interest from this sector can be found on page 10. This sector promises to provide significant job opportunities for local residents and strong tax revenue which will enhance services provided to County citizens. Hanover County's GDP has grown to \$7.9 billion, which represents an increase of 12.7% since 2021 and ranks 19<sup>th</sup> in Virginia localities. The County's labor force has hit an all time high of 62,768 and unemployment remains well below State and national averages. Regional collaboration has continued to highlight tourist assets, ranging from Kings Dominion to the rapidly expanding agritourism sector, with Hanover County witnessing record visitor expenditures of \$229 million in CY 2023 and record hotel tax revenue of more than \$1.5 million generated in FY 2024.

Moving into FY 2025, the Department of Economic Development will continue to work closely with partners to establish an updated strategic plan, and anticipates launching a refreshed and retooled website in the spring. The Economic Development Authority will continue to work closely with the Department to become more active this year with a strong goal of promoting strategic investments in key industrial and commercial areas. And of course, we will continue to work closely with new and existing businesses, as well as entrepreneurs and small business owners, to ease barriers of operation where possible, allowing for continued growth and expansion to provide more opportunities to our growing community.

In closing, I wish to give thanks to County leadership, regional and State partners, citizens and businesses of Hanover County, and all stakeholders who work with the Department of Economic Development to grow and enhance the Hanover economy. Successes highlighted in this year's report are all a reflection of your hard work, dedication, creativity, and love for this community!

# **ABOUT HANOVER COUNTY**

With record employment and GDP numbers, along with dozens of new companies and expansion projects, Hanover County's pro-business environment continues to show results.

Sectors such as warehousing and logistics have cooled somewhat from pandemic highs, but are still historically robust as Hanover, and the Richmond Region, continues to prove strong value as a logistics hub. Increasing interest in the region from manufacturing, construction, and data center sectors will bring economic diversity to the region in the coming years. Thanks to years of success and increased visibility on the national and international scenes, Hanover continues to be a wonderful place in which to live, play, and conduct business.

Many reasons businesses continue to express interest in Hanover County include:

#### **MARKET PROXIMITY**

Access to I-95, I-295, I-64 and other major highways places Hanover County within a day's drive of nearly half of the population of the United States, and is especially close to major Northeast markets.

#### STRONG, WELL RUN GOVERNMENT

Hanover County is one of the smallest U.S. counties by population to have a AAA bond rating from all three bond ratings agencies. Fiscal stability is paramount to the County. Additionally, businesses reap the benefits of a low, stable tax structure and minimal business regulation.

#### Hanover County Economic Development Authority

The Hanover County Economic Development Authority (EDA) is a seven-member appointed board established by the Hanover County Board of Supervisors in 1967 pursuant to the Industrial Development and Revenue Bond Act to promote industry and develop trade by inducing manufacturing, industrial, and commercial enterprises to locate in and/or remain in the Commonwealth and Hanover County.

In the past year, the EDA has become more active in economic development by engaging in increased dialogue and guidance with the Board of Supervisors. This was especially evident in the EDA's support of the Comprehensive Plan, Envision Hanover, approved by the Board in September 2023 (see page 30), and the EDA's support of the Tract Technology Park rezoning in March 2024 (see page 11). The EDA took a very active role in the Board of Supervisors workshop in May 2024 (see page 30). These initiatives are adding increased value to the EDA's role in promoting more strategic economic development projects in the community. And, the Board has begun equipping the EDA with tools, guidance and support to assist with site development and business attraction/retention initiatives.

Presently, the EDA is ramping up promotion of Industrial Revenue Bonds. Issued through the EDA with no liability on the Authority, these bonds pay fees to the EDA which can then be utilized to fund economic development initiatives within the County. Due to the EDA's increased activity, meetings are now held bi-monthly instead of quarterly.

# **PRODUCT DEVELOPMENT**



#### During Fiscal Year 2024, several speculative industrial developments were completed and became available for lease/sale while developers also started to address the need for smaller flex spaces and sites in the County.

According to a February 2024 CoStar report, the Richmond region is cited as one of the tightest markets in the country for available industrial space. A reshoring of industrial-related jobs and the region's business-friendly environment have pushed industrial users to quickly absorb existing stock. Much of the demand has come from logistics and distribution operators wanting to be along the state's most traveled interstates, giving these operators access to some of the largest population areas in the east. These factors, along with the evergrowing Port of Virginia, will likely help keep availabilities low in the near term. With an availability rate of 2.6 percent for properties smaller than 50,000 square feet, developers are beginning to address this market with new product.

#### I-64 Industrial Park

After securing zoning approvals from Hanover County and Goochland County, a local development team will construct a new industrial park straddling county lines that will add needed inventory to the region's office/warehouse and flex space market. Located at 1468 Pony Farm Road beside the existing Oilville Business Park, the I-64 Industrial Park consists of approximately 44 acres in Hanover and 40 acres in Goochland. The park offers 14 lots (5 lots are in Hanover County) ranging in size from 2.5 to 6 acres and will be accessed from Goochland County via a road ending in a cul-de-sac. With outdoor storage allowable on the site, it is expected that the park will appeal to such users as service contractors, HVAC groups, pipe fitters, electricians and landscaping companies.

# **DATA CENTER DEVELOPMENT**

The pandemic accelerated the use of digital platforms and cloud services, generating a surge in data center development. Rapid growth continues to be driven by technological advancements and increasing power demands of hyperscalers.

The I-64 Innovation Corridor map on the following pages details the reasons the Greater Richmond Region is critical to data center expansion. Most facets of every day life in today's world begin or end in a data center. From banking to GPS to social media and video streaming, data centers play a pivotal role in the way we see, store, and calculate information. Photos, bank and medical records, and so much more are housed in these facilities.

What exactly is a data center? In short, data centers are buildings which house the digital infrastructure necessary to facilitate cloud computing and make technologies like 5G and artificial intelligence (AI) possible. Due to the growth in cloud computing and anticipated significant demand for data centers to accommodate AI growth, the need for these facilities is exploding. McKinsey and Company, a global

management consulting firm, anticipates the sector growing by 10% annually through at least 2030, with the U.S. accounting for roughly 40% of the global data center market.

Traditionally, Northern Virginia has been home to the world's largest concentration of data centers. However, due to the scarcity and increased prices of land and challenged electric transmission capacities, the industry is expanding beyond that region. Hanover County, and the Greater Richmond Region, has become an area of significant focus for the industry due to the availability of land, strong power generation and distribution, and proximity to several global fiber optic lines. Hanover County is positioned well to locate data center projects, and interest in the County from this sector is extremely high.

The data center sector is a rapidly evolving industry. Operators of these facilities have become more responsive to climate and citizen needs and are constantly upgrading technologies to limit noise, enhance setbacks and screenings, and reduce demand on electric and water infrastructure. Data centers built today are increasingly consolidating into larger facilities, yet are significantly more efficient and quiet than facilities built years ago.

## Tract Technology Park in Hanover County





#### **Project Timeline and Details**

In September 2023, an application was filed with Hanover County's Planning Department indicating Tract, a data center land development company based in Denver, Colorado, wished to rezone over 1,200 acres of land north of the Town of Ashland and partly adjacent to 1-95 for data center use. This land has been identified in Comprehensive Plans dating to 2007 as an area of future economic development growth. Several public meetings were held where the project was put forth for the community to provide input and ask questions. Tract worked closely with various County departments, Planning Commission, Economic Development Authority, and Board of Supervisors to incorporate feedback into the final rezoning plan. Feedback incorporated included additional building setbacks, enhanced buffering and screenings, noise attenuation measures, and reduced building heights in portions of the park. Satisfied with how the final rezoning application was structured, the Board of Supervisors approved rezoning of the campus to M-1 (manufacturing) use on March 27, 2024. All uses except for data center use have been proffered out for the entire campus.

Hanover County is working closely with Tract on the next phase of development of this technology park. The company anticipates investing \$50-\$100 million in infrastructure and site readiness on the 1,200 acres. The County will work with Tract on installing water and sewer infrastructure to the property. Road upgrades were voiced as a major concern by citizens during the rezoning process; Tract has agreed to provide Hanover County with \$3.5 million to go towards needed road upgrades with the County providing additional funding. Additionally, Tract will contribute \$100,000 to the enhancement of Washington Lacy Park. Preservation of the park was another concern for residents in the area, and this contribution will go towards enhancing amenities currently in the park with possibility of adding other amenities. In the past, this acreage was identified as a major economic development area which could handle significant industrial development and included a concept road to bisect Washington Lacy Park from south to north. As data centers generate minimal traffic upon completion, the need for this roadway is no longer present and has been removed from the Comprehensive Plan, thus providing more protection for the park in the future.

To be developed over the next 20 years, this property sets the stage for up to eight data center campuses to be constructed. Data centers are taxed on real estate and business tangible personal property. Because of the significant investment anticipated in this park (\$10-\$15 billion at build-out), the County will realize significant growth in tax revenue, with projections indicating the first 20 years of the park would contribute up to \$1.78 billion in revenue. This is revenue which can be invested in community needs, such as enhanced Fire/EMS coverage, school construction/renovation, park enhancement and development, and/or tax relief among other possibilities.

## **BUSINESS** INVESTMENT

Job creation continues to soar and capital investment remains robust thanks to strong diversity in projects coming to the community.



**CEEUS**, Inc., a member-owned electrical distributor that serves cooperatives, municipals, and investor-owned utilities, and offering services such as tool repair and a rubber goods testing facility, announced in December 2023 of its investment of \$37 million to establish a 187,000 square-foot warehouse and distribution facility in Cardinal Commerce Center in Hanover County to support customers in Virginia, Maryland, and Delaware. Virginia successfully competed with North Carolina and South Carolina for the project, creating 30 new jobs. The Virginia Economic Development Partnership worked with Hanover County and the Greater Richmond Partnership to secure the project for Virginia.

U.S. Cabinet Depot, a Georgia-based cabinet supplier, announced in June 2024 of its commitment to occupy 194,400 square feet of a nearly 316,000 square-foot building that will make up the second phase of North Richmond Industrial Park located off of Washington Highway in Hanover County. The company intends to use the space as an East Coast distribution and logistics center and employ 60 people. Set to open in the fall of 2024, the facility is U.S. Cabinet Depot's 8<sup>th</sup> warehouse. Constructed on spec, the building is a cross-docked warehouse with 36-foot-high ceilings, 78 dock doors and four drive-in docks. The parking lot includes spaces for 240 cars and over 100 trailers.





#### **National Tank & Equipment**

National Tank & Equipment (NTE), a Texas-based provider of liquid handling solutions, announced in June 2024 of its presence in the mid-Atlantic with the opening of a new facility in Hanover County. The Ashland branch is only 20 minutes from Richmond and features a 1.5acre fully fenced yard, warehouse and office space. This location is the 21<sup>st</sup> addition to NTE's network spanning Pennsylvania, Maryland and Texas.

#### **Truck Enterprises**

Truck Enterprises, founded in 1961 in Harrisonburg, VA, broke ground in September 2023 on a new 80,000 square-foot facility located off of Sliding Hill Road in Ashland, VA. The new truck center will have 24 service bays, a body shop with 18 additional bays, an extended parts inventory, new and used truck sales, and truck rental and leasing. It will employ 80 people of which 20 will be new hires.






Sancerre Atlee Station, located adjacent to the Atlee Station Family YMCA in the heart of the Atlee area in Hanover County, is a new senior living community which opened in July 2023. The facility provides 103 exceptional accommodations, 79 for assisted living and 24 for memory care, with high-caliber healthcare and daily activities tailored to different levels of lifestyles and care based on residents' needs.

Increased population growth and tourist visitation have resulted in a surge of new dining and retail operations, as well as additional commercial development to address record low retail vacancy rates.







Blake and Coe

**Blake & Coe**, a women's western clothing, footwear and accessories boutique, opened in July 2023 at 11670 Lakeridge Parkway in the Winding Brook retail development. The locally owned retail store also has a Short Pump location. **Intermission Beer Company**, a husbandand-wife-led craft brewery founded in Henrico County, has expanded to Hanover County. The new location at 10180 Lakeridge Parkway is off Interstate 95 near Green Top Sporting Goods.

Opened in 2023, this establishment is 7,100+ s.f. with a dining room, large bar, pizza oven, outdoor patio and an arcade.



#### **Business Investment: Food Service**

Padow's Deli, a longtime staple of the Richmond area, opened its newest location at 11000 S. Washington Highway in Glen Allen next to the Hanover Sports Park. The deli specializes in handmade sandwiches.

**Eggs Up Grill** opened its Brandy Creek Commons location at 6593 Mechanicsville Turnpike on May 13, 2024. The restaurant occupies a 3,500 s.f. building with indoor seating for up to 150 customers.

**Olde Towne Smokehouse**, opened on May 31, 2024 at 8011 Cold Harbor Road in Mechanics-ville, serves BBQ and delicious sides with a craft approach and a decidedly Southern twist.

Hooked Seafood & Raw Bar opened on May 1, 2024 at 6078 Mechanicsville Turnpike. Locally owned and operated, the restaurant sources local fresh seafood to craft delicious dishes.

Hanover Smokehouse opened on March 15, 2024 at 8100 Creighton Parkway in Mechanicsville. Owned and operated by the United Restaurant Group, the restaurant specializes in traditional southern barbecue.







#### Up and Running: Corporate Investment Updates



**Performance Food Group, Inc.,** the Goochland, VA-based Fortune 500 food distribution company, held a ribbon cutting ceremony on September 20, 2023 and started operations the following month at its newly built 332,000-square-foot sales and distribution center. Located at 10399 Washington Highway in Cardinal Commerce Center just south of the Town of Ashland at the intersection of Route 1 and Cedar Lane, the facility is anticipated to employ 650 people.



**Wegmans Food Markets, Inc.**, a grocery retailer with stores throughout the Northeast and mid-Atlantic, announced in December 2019 of its planned 1.1 million-square-foot regional logistics and office operation in Hanover County, representing \$175 million in capital investment and creation of 700 new jobs. Construction was completed and the facility operational by the end of 2023.

# **BUSINESS EXPANSIONS**



Virginia Artesian Bottling Company announced its \$3 million investment to expand in Hanover County in October 2023. Located in Mechanicsville, the company will expand its warehouse space to increase capacity and add an additional blow mold line to its existing operations. The project will create 13 new jobs.

Founded in 2002, Virginia Artesian Bottling Company is a family-owned and -operated company that sits on two deep, stone-protected aquifers, enabling bottling of water right at the source to retain the purity and clean, crisp taste.

The company bottles water, including custom branded labels and bottles, for various entities from universities to hotels across the nation.

The Virginia Economic Development Partnership worked with Hanover County to secure the project for Virginia and will support Virginia Artesian Bottling Company's job creation through the Virginia Jobs Investment Program (VJIP), which provides consultative services and funding to companies creating new jobs in order to support employee recruitment and training activities. As a business incentive supporting economic development, VJIP reduces the human resource costs of new and expanding companies. VJIP is state-funded, demonstrating Virginia's commitment to enhancing job opportunities for citizens.

Virginia Artesian Bottling Company earned recognition in the Richmond BizSense **Keiter** 2023 RVA 25 list of fastest growing companies in the region. Ranking at #13, the company realized a 100% annual growth rate over the past three years.



#### **Business Event Collaborations Offer Cost Free Programs**

Hanover County encourages small businesses to innovate, prosper. and grow here. Through an extensive network of resources and partnerships with other public and private organizations providing small business and entrepreneurial assistance, HCED frequently cosponsors workshops, seminars and events on a wide variety of business topics. HCED teamed up with SCORE Richmond mentors to



provide business mentoring sessions throughout the year at various locations throughout the County. In May 2024, an in-person workshop led by Megan Nolde, Client Services Coordinator and Business Advisor for the Capital Region Small Business Development Center (SBDC), presented basic brand identity principles and how to incorporate visuals and written words in that brand identity. Hanover County and the Town of Ashland provided endorsement to the Downtown Ashland Association to supports its 2024 Entrepreneurship Initiatives funded through grants totaling \$175,000 from the Virginia Department of Housing and Community Development. As part of these initiatives, a series of business innovation workshops were offered free of charge.



#### **Business First Hanover's Valuable Outreach**

Hanover County Economic Development continued its business outreach utilizing staff and volunteers through its Business First Hanover program. Three business walks were conducted through this program in FY 2024 concentrating in the Hanover Industrial Air Park and Olde Towne Mechanicsville. A total of 69 businesses were visited just on these walks alone! Volunteers are paired with a experienced "business walker" to distribute relevant information to businesses and to gather data, identify needs of the company, and inquire about industry trends.



The Dominion Energy Innovation Center (DEIC), established in 2009 in Ashland, VA, is a clean energy incubator and independent nonprofit public-private partnership founded by Dominion Energy,

Hanover County, the Town of Ashland, and Activation Capital. The DEIC prioritizes community building and startup support at all stages of the journey. By fostering collaboration, providing resources, and offering guidance, the Center supports clean energy companies helping drive sustainable solutions while building a strong entrepreneurial community across Virginia and beyond.

The Ag-X workshop series is a collaborative effort by SCORE Richmond and the DEIC. Designed to foster growth and strengthen the regional economy, this six-week program equips agribusiness participants with essential tools, principles, and industry connections necessary for success.

Located in a renovated firehouse, DEIC also offers a unique coworking space for startups, early stage businesses, and creatives to call home.

#### During FY24, our department conducted 157 business visits and assisted 124 Hanover businesses.



#### Ag-X Workshop Scholarships



HCED offered scholarships to Hanoverbased businesses interested in attending the agricultural workshop series. Two Hanover-based agricultural businesses applied and received tuition reimbursement upon successful completion of the in-depth five-part series.

## **MARKETING & PROSPECT DEVELOPMENT**







Promotion of a community's business sites and resources is a critical function of an economic development department, and Hanover County Economic Development (HCED) works closely with the Greater Richmond Partnership (GRP) and Virginia Economic Development Partnership (VEDP) to spread the word that Hanover is a wonderful place to conduct business.



Through in-market visits, external outreach, and virtual meetings, HCED witnessed another robust year of lead and prospect generation. In FY 2024, HCED responded to 79 prospect inquiries, which are

considered projects that are actively scouting for sites and/or buildings in which to establish a new or expanded operation. These prospect leads represent a diversity of industrial sectors such as pharmaceutical, data center, electric vehicle supply, logistics, and other advanced industrial uses.



HCED also hosted 83 prospect visits to the community during FY 2024. Since COVID, there is an emphasis on virtual visitation and meetings, especially in the early stages of site section. But there continues to be strong, and

growing, interest for in-person meetings, which are more conducive to business and relationship development. HCED has also been active visiting external markets and meeting with site selection consultants who are working a number of expansion projects, further educating on reasons to consider Hanover for a prime business location.



#### SEDC Annual Conference, Williamsburg

HCED's Brandon Turner attended the Southern Economic Development Council (SEDC) Annual Conference held in Williamsburg, VA in August 2023. Attended by 400+ economic development professionals, site selection consultants and industry experts, this event provided an outstanding opportunity to network and learn from counterparts throughout the Southeast. The 3-day agenda featured numerous speakers, breakout sessions, and networking opportunities.

#### Washington D.C. Marketing Mission

In collaboration with the Greater Richmond Partnership and regional partners, Armon Smith with HCED visited with several embassy representatives in Washington D.C. in November 2023. Embassy visits are a great way for the region to promote foreign direct investment into the market. During the visit, the group also met with several site consultants and Miltton USA, a D.C based group assisting Nordic companies in business expansion into the U.S

#### Atlanta InterCity Visit



ChamberRVA's InterCity Visit program enables an environment where the Richmond Region's leaders can engage in meaningful dialogue and generate innovative ideas from peer cities. The 2024 visit to Atlanta, GA was held from April 29<sup>th</sup> – May 3<sup>rd</sup>, and was attended by HCED's Brandon Turner, County Administrator John Budesky, and Board of Supervisors members Faye Prichard, Sean Davis, and Ryan Hudson.

#### **Bio International Convention, San Diego**

The largest and most comprehensive event for the full biotech ecosystem, Bio International took place in San Diego in June 2024 with over 18,000 attendees. In collaboration with the Greater Richmond Partnership, Brandon Turner with HCED attended the conference, meeting with dozens of companies and industry experts representing a variety of biotech businesses throughout the world







#### **Regional Marketing Mission to Japan**

Hanover County Economic Development's deputy director, Armon Smith, and local partners from the Greater Richmond Partnership, Henrico and Richmond visited Japan in March 2024 to meet with companies considering an expansion in the Greater Richmond Region. Currently, there are ten Japanese-owned companies in the Richmond metro area including one in Hanover County. Over five days, the group met with U.S. Embassy representatives and nine companies across various industry sectors ranging from food manufacturing, pharmaceuticals to semiconductors. The marketing and business attraction team also visited Richmond's sister city of Saitama.

While in Japan, Armon had the opportunity to visit Morooka Co. Ltd., the parent company to Morooka America LLC, and its collaborative partner, Morooka USA, both located in Hanover County. As one of the trailblazers in bringing high-demand compact construction equipment to market in North America, Morooka USA is a master distributor to Japan's Morooka Co Ltd. The U.S. distributor, based in Ashland, VA, supplies its versatile machines to approximately 150 dealers across the United States and Canada. A related company also located in Ashland, Morooka America LLC, is owned by the Japanese conglomerate and serves as the exclusive American manufacturing plant for its rubber-track carriers.



Marketing Collateral

HCED customized its informational marketing flyer by utilizing Syncroz, a Hanover-based company specializing in language translation, to convert English text to Japanese. The flyer included basic information about Hanover County and the Richmond region including location, proximity to other major cites and markets, industry sectors, international companies, statistical data, accolades, demographics, cost to do business. and guality of life. A QR code was affixed to the department's business cards that provided direct access to the department's website conveniently displayed in Japanese using Google Translate. As a small token of appreciation for the opportunity to meet with Japanese business leaders, custom branded tomatoes, an iconic crop in Hanover County, with the department's logo and website address were distributed to the companies visited.

#### Familiarization Tours Provide Firsthand Knowledge of Hanover County

When promoting a county and the region's sites and buildings to external businesses, it is imperative economic development professionals and site selection consultants truly understand the community's assets. This is best handled through familiarization tours, where attendees are provided tours not only of the community's real estate assets but also neighborhoods, schools, parks, restaurants, and other resources and amenities. It is important to showcase the entire ecosystem to economic development

professionals and consultants so they can relay a community to business prospects. Understanding of a community's true character and assets is important because businesses do not choose locations based on real estate alone: they are looking for a community in which their values and needs are fully met. HCED took part in several familiarization tours in FY 2024, providing comprehensive tours for over 40 site selection consultants, state and regional economic development professionals, and local leaders.

#### Hiring In Hanover, VA App Connects Businesses and Jobseekers



As businesses pivoted to adjust to new working conditions created by the pandemic, HCED's outreach efforts quickly uncovered the need for a local job board to assist businesses and job seekers. Hanover County Economic Development created the Hiring in Hanover, VA App in July 2020 using the Glide web-based platform to satisfy numerous requests from Hanover-based businesses. Anyone can access the app from any device whether it be mobile, tablet, or desktop, and the app can easily be shared with a web link or QR Code. The app has been well-received, and the businesses are appreciative of the department's efforts and marketing exposure of their employment needs. The department continues to explore more options for app enhancements and broader marketing opportunities. Since its inception in July 2020, the app has received more than



8,700 views. In addition to social media posts and newsletter features, the app is routinely promoted through business visits and Business First walks.

#### **HCED Debuts Department's E-Newsletter**

To enhance communication efforts, the Department of Economic Development debuted its first e-newsletter in February 2024. Published and distributed monthly, this valuable marketing tool brings attention to new businesses to the County, existing business expansions, announcements, data releases and trends, department and County initiatives and events, as well as business relevant seminars, workshops and partner events. To assist with site location and workforce needs, the newsletter also spotlights featured properties and Hanover-based employer job openings. Debuting at 200 subscribers, the newsletter distribution list has grown to more than 400 recipients.





## Hanover Shopping Season Campaign

Throughout November and December of 2023, our department encouraged consumers through its Hanover Shopping Season campaign to "Shop Local" and to consider dedicating part of their holiday spending in support of local and small businesses. The campaign touted the County's retail establishments, restaurants, personal service providers, and other businesses that count on customer patronage. The campaign was promoted through social media posts and print ads in The Mechanicsville-Ashland Local, and encompassed Black Friday Shopping Deals, Shop Small Saturday, and Cyber Monday. A special blog post with social media shares encouraged consideration of support to local nonprofits on Giving Tuesday. The hashtag #HereInHanoverVA was used on all posts. Citizens and businesses are also encouraged to use this hashtag to share everything wonderful about Hanover. Hanover Shop Local Season leverages the Shop Local-#HereInHanoverVA campaign. and utilizes the Here In Hanover, VA App which features restaurants, specialty shops, breweries, wineries and fun things to do in Hanover County. During the campaign, the app's homepage was modified to market Hanover Shopping Season. The app also provides a link to ZoomBusiness-Hanover which is a free directory available to all types of businesses to be included.

## May 2024 Promotional Campaigns

During the month of May 2024, Hanover County Economic Development continued promotion of its educational social media campaign to recognize the Small Business Administration's Small Business Week (April 28-May 4), International Economic Development Council's Economic Development Week (May 6-10) and Virginia Business Appreciation Month. During the first week, posts provided tips on ways to support and promote small businesses. The second week included daily posts educating about the important functions of economic development organizations. In recognition of Virginia Business Appreciation month, our department shared business workshops and provided workforce assistance through promotion of the department's Hiring In Hanover, VA App.









#### USDA Releases 2022 Census of **Agriculture Data**



The U.S. Department of Agriculture's National Agricultural Statistics Service announced the results of the 2022 Census of Agriculture on February 13, 2024,

spanning more than 6 million data points, down to the County level, concerning America's farms and ranches and the people who operate them. Conducted every five years, ag census data provide valuable insights into demographics, economics, land use and activities on U.S. farms and ranches. The nationwide response rate for the 2022 Census was 61% with more than 40% of responses submitted online.

Some of the key findings for Hanover County reported from the 2022 Census of Agriculture include:

- Following nationwide and State trends, the Census reports a 10% decrease in the number of farms since 2017 with 512 active farms counted in 2022. Hanover farms comprise an average size of 179 acres (up 14%) on 94,864 acres of farmland (increase 3%). That is 21.5% of Hanover County's total 301,000 acres.
- Hanover represents 1% of Virginia's agriculture output, totaling nearly \$64 million for products sold (a 30% increase from 2017) and placing the County 20<sup>th</sup> from 98 producing counties in Virginia.
- Net cash farm income has increased 100% from \$6.75 million in 2017 to \$13.5 million in 2022.
- The total number of producers in Hanover has decreased slightly between 2017 and 2022, from 898 to 876.



In Hanover County, an increasing number of working farms are inviting visitors to enjoy hayrides, pick and buy their produce, attend festivals and events, and hold weddings and parties. These agricultural tourism offerings allow visitors to enjoy, be educated, or be actively involved in the activities of the farm or operation – getting a true farm experience. Agri-tourism also allows farmers to supplement income earned from traditional farming, allowing them to continue keeping long-term farms profitable and in family ownership. The 2022 Ag Census reported that the number of farms deriving income from agri-tourism and recreational services in Hanover County has increased 189% from 9 farms in 2017 to 26 farms in 2022 with income skyrocketing 970% from \$64,000 in 2017 to \$685,000 in 2022.

more than \$229 million was spent by visitors in Hanover County in calendar year 2023, a 2.8% increase over the previous calendar year and a new high record. Virginia's tourism industry generated a record high \$33.3 billion in visitor spending in 2023, an increase of nearly 10% from the previous year with the Central Virginia Region accounting for nearly \$5.8 billion of the state's total, which is a 6.5% increase from 2022. The tourism industry in Virginia directly supported over 224,000 jobs in 2023, an increase of over 13,000 jobs relative to 2022.

According to the 2023 Economic Impact of Visitors in Virginia prepared for the Virginia Tourism Corporation,

\$1,555,015 HOTEL TAX REVENUE (FY24) Source: Richmond Region Tourism In Hanover County, local tax receipts for the 2024 fiscal year generated \$1,555,015 in lodging taxes, which represents an 6.2% increase from last fiscal year. The County, along with the Richmond Region as a whole, set another year-over-year record for annual occupancy tax revenue in FY 2024. Beginning July 2023, the Richmond area's Tourism Improvement District (TID) initiative began collecting an additional 2% fee on nightly hotel rates to help Richmond Region Tourism attract and entice events, sports, meetings, and conferences to the region. The first year results of the 14 TID Campaigns launched and completed can be found on page 31.

#### Hanover Parks & Recreation Rolls Out New Events

Winter on the Green, a new event hosted by Hanover County, kicked off the holidays on December 9, 2023 at the Historic Hanover Courthouse Green. The event started off with a grand illumination followed by horse carriage rides, visits with Santa Claus and other winter characters, cookie decorating with Mrs. Claus, hot chocolate and ornament crafts. Enthusiatically received by attendees, Winter on the Green is scheduled to be held again in December 2024.

**History and Hops** is another new event hosted by Hanover County that featured costumed interpreters, demonstrations, unique entertainment, an assortment of craft beer options, and a variety of other activities. Attendees experienced the sights and sounds of the American Revolution at this event on June 2, 2023 as the state of Virginia kicked off the VA250 campaign. History and Hops was held again at the Historic Hanover Courthouse on May 3, 2024.

#### HANOVER COUNTY VIRGINIA AMERICAN REVOLUTION

The Declaration of Independence, written primarily by Virginia's Thomas Jefferson, was signed by fellow members of the Continental Congress on July 4. 1776. Hanover County has joined with participating localities across Virginia to commemorate the 250<sup>th</sup> anniversary of the American Revolution. In September 2022, the Hanover County Board of Supervisors adopted a resolution in support of the commemoration and authorized the appointment of a local VA250 committee to plan and coordinate County programs and events leading up to and during 2026.

#### New Extended-stay Hotel Opens in Winding Brook

WoodSpring Suites by Choice Hotels, managed by Holladay Hospitality Group, is a four-story, 122 room extended-stay hotel which broke ground in 2022 and opened in August of 2023. Located at 11530 Lakeridge Parkway in Ashland, VA, near Bass Pro Shops, this hotel features four stories with a variety of rooms with queen or king-sized beds, a spacious lobby, guest laundry room, and fitness center. Each of the furnished suites offer a comprehensive kitchenette, a flat-screen TV, a well-appointed workspace featuring a comfortable chair, a cozy bed, and ample storage space.



#### **Shalom House Retreat**

Shalom House Retreat, located on 90 acres of beautiful wooded land and open fields in the quaint little village of Montpelier, offers a peaceful serene environment to guests for private retreats, family reunions, youth gatherings, church picnics, small group meetings, corporate retreats, and more. The property features a historic farm house, the Shalom House, that overlooks the fouracre Lake Shiloh. Also being marketed as a wedding venue, the Shalom House offers a beautiful meeting room, full commercial kitchen and two adjacent guest lodges with eight bedrooms each. The property was previously owned by the Catholic Diocese of Richmond. A ribbon cutting ceremony coordinated by the Hanover Chamber of Commerce was held on April 4, 2024.

The Event Barn at HVF The Event Barn at the Hanover Vegetable Farm (HVF) provides an added experience during concerts and festivals. With multiple seating areas, 30 plus televisions, food and beverages, fans have the opportunity to experience events unlike any other local venues. Adjacent to The Event Barn, The Pavilion at the Hanover Vegetable Farm is a hidden gem in Hanover County that offers a down-on-the-farm experience for concerts, festivals, and private events. Offering some of the best sunsets in Hanover County, a family friendly atmosphere, and multiple seating options, the venue is quickly becoming one of Central Virginia's top destinations. The Five O's Tiki Foundation coordinates many concerts held at HVF and Richmond Harley Davidson in Ashland, VA







#### The Virginia American Revolution 250 Commission (VA250) was created by the Virginia General Assembly for the purpose of planning for and commemorating the 250th anniversary of Virginia's participation in American independence.







#### Green Top Outdoor Expo 2023

Green Top, located near Ashland, held its annual Outdoor Expo over two days on the first weekend of October in 2023. Attended by tens of thousands of hunters, anglers, and outdoor enthusiasts of all ages, the family-friendly event offered free admission and parking, 200+ top vendors from the outdoor industry, fun kids' activities, product demos, show specials, great food, live music, special guests and prize drawings. In addition to applying and receiving a Hanover County Sponsorship for the 2023 event, Green Top has been awarded \$27,000 in combined grant and sponsorship funds through Virginia Tourism Corporation to help promote and offset production costs of the 2024 Expo occurring on October 5<sup>th</sup> and 6<sup>th</sup>

## **COUNTY & DEPARTMENT INITIATIVES**

#### **Economic Development Strategic Plan**

Upon adoption of Hanover County's Comprehensive Plan Update, Envision Hanover, on September 27, 2023, several strategic planning initiatives in a number of County departments have commenced. Included in this round of strategic planning is the Economic Development (ED) Strategic Plan, last updated in 2015. It will come as no surprise the County's economy has changed dramatically since that plan was established. Originally scheduled to be updated in 2020, COVID-19 put a temporary delay on the initiative. Since the Comprehensive Plan was scheduled for updating in 2023, it was determined best to put the ED plan on hold. As the Comprehensive Plan helps guide where development will take place, and the recent Industry Cluster Analysis informs what sectors to target, the Economic Development Strategic Plan will piggyback on these plans to determine the best strategies to guide strategic, targeted, high-quality investment into areas best suited for the use. As part of this future strategic planning, Economic Development will be provided with an updated set of performance measures to maintain and analyze to determine if the plan is meeting its goals and objectives. These measures will continue to be reported to the Board of



The Comprehensive Plan is a longrange guide for growth and development, establishing a vision of what Hanover County could look like in twenty years. The plan addresses a variety of topics, including land use, housing, economic development, and natural resources. It identifies objectives and strategies that can be implemented to realize the community's vision. Throughout 2022 and

2023, Hanover County worked with residents, businesses, landowners, and other community members to update this guiding document. This latest version of the plan, which is called Envision 0 Hanover, was adopted on September 27, 2023.

Supervisors and to the community through the Department's Annual Report and State of the County address. Given the dynamic and competitive nature of the larger economy, and desire to encourage and retain intentional, targeted projects into key areas identified in the Comprehensive Plan, Hanover County must proactively nurture and develop its business sector to address global economic conditions as well as needs of the local community.



#### EDA Participates in Workshop with Board and County Staff

The Hanover County Board of Supervisors held a two-day workshop on May 14 and 15, 2024 at the Federal Club near Montpelier. The goal of the workshop was to discuss a number of topics guiding the County, including goal setting, process review, strategic plan and Comprehensive Plan review. The Board looked closely at the County's Economic Development Zones, and provided rankings of the zones to prioritize small area planning. The Board also engaged with the Economic Development Authority (EDA) and provided guidance for the EDA to move forward with assisting the Department of Economic Development in site development, incentive policy, and other economic development initiatives.

#### **Regional Initiatives**



#### **GRTC LINK Microtransit**

The Greater Richmond Transit Company (GRTC) celebrated its newest LINK service for the Ashland Zone with a ribbon cutting ceremony at Ashland Town Hall on March 18, 2024. GRTC's LINK, which launched fare-free, is an on-demand microtransit service that provides point-to-point connections across delineated community zones. To schedule a ride, a user can simply enter the desired pick-up and drop-off locations within the zone using the GRTC On the Go app or by phone call, and a vehicle will arrive within 20 minutes to take the rider to that location. In November 2023, GRTC started the LINK pilot route in the Azalea/Mechanicsville Zone, which includes Bon Secours Memorial Regional Medical Center and Old Town Mechanicsville. Microtransit service is also available in several additional LINK zones throughout the Greater Richmond Region.



#### **Talent Pathways Initiative**

The Talent Pathways Initiative (TPI) is a program of the statewide Go Virginia Board funded with amendments adopted to the FY '22 budget. The initiative outlines that the Planning Grant shall support analysis of the workforce needs of regional businesses and identification of the skills and training that can help prepare Virginians to fill available jobs in regional markets. In 2023, the Go Virginia Region 4 Council began accepting Letters of Interest from organizations with a presence in the Region 4 footprint interested in serving as a Coordinating Entity for all or part of the TPI to work along side the Grow Capital Jobs Foundation. The Go Virginia Regional Council 4 has selected two priority industry clusters to be the focus of its TPI application to address regional workforce shortages and skills gaps: Advanced Pharmaceutical Manufacturing and Information Technology,

#### **Fall Line Trail**

The Fall Line Trail (FLT) is a regional multi-use trail that was conceptualized in 2019. The Virginia Department of Transportation (VDOT) conducted a study to determine an alignment for a 43-mile regional trail. The final report, published by VDOT in February 2020, outlines the preferred corridor from Ashland to Petersburg. The trail system was then renamed to reflect the natural and geographic character of the region – The Fall Line Trail. The first segment of the FLT, the Trolley Line Trail in Ashland, led to the idea of expansion into a multi-jurisdictional trail system. On April 24, 2024, a groundbreaking event was held to ceremoniously mark the start of construction on the 4.8-mile stretch of the trail that will traverse Hanover County. The FLT will run through Richmond, Henrico, Chesterfield, Hanover, Ashland, Petersburg and Colonial Heights.















**AVERAGE ANNUAL WAGES** 



### **NET NEW JOBS IN ALL INDUSTRIES**




## **NET CHANGE IN NUMBER OF JOBS PER TARGET INDUSTRY**







#### PERCENTAGE OF TOTAL TAXABLE ASSESSED VALUE BY PROPERTY TYPE






#### **VACANCY RATES BY PROPERTY CLASS**
